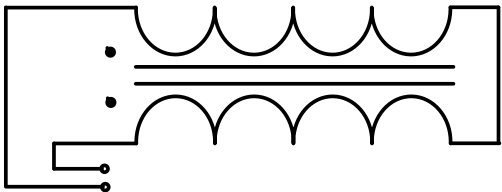
Typical Insertion Loss:



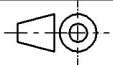
Test Setup:



Common Mode

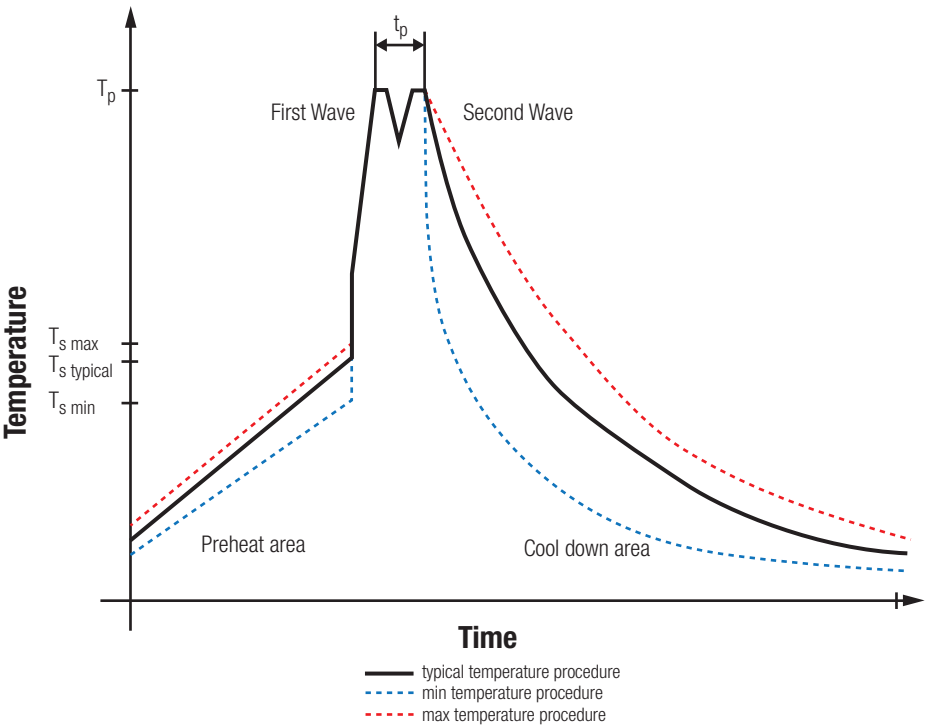


Differential Mode

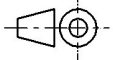

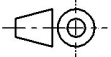

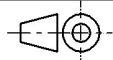
