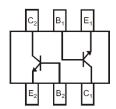

Device Schematic Top View

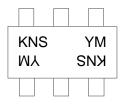

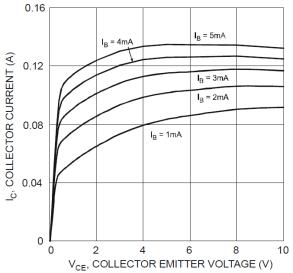
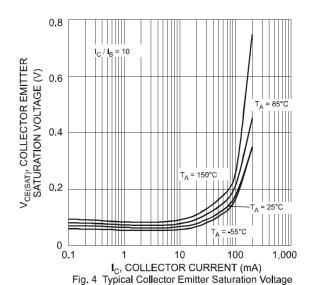


Fig. 2 Typical Collector Current vs. Collector Emitter Voltage

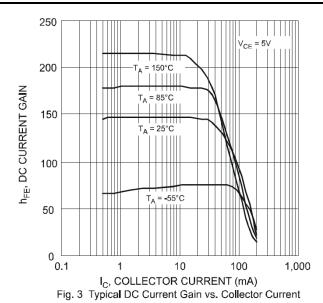

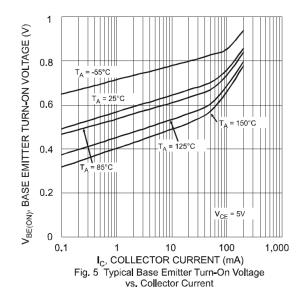

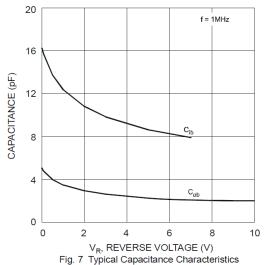

vs. Collector Current

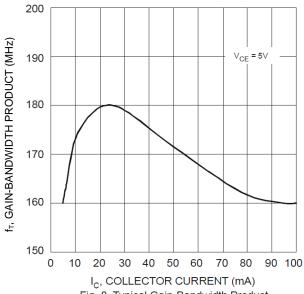
